## **SUMMARY OF REPORT:**

The report presents an overview of the statutory requirements to establish an Integrated Care Partnerships and identifies and proposes the NHS Humber and North Yorkshire Integrated Care Board founder members for approval by the Board.

The Health and Care Act 2021 sets out four core elements to an Integrated Care System which are Place, Provider Collaboratives, Integrated Care Board and an Integrated Care Partnership (ICP).

The ICP is statutory committee that is expected to be jointly developed between the ICB and Local Government.

The ICP is expected to work with Partners wider than the ICB and is required to develop an integrated care strategy to address the health, social care and public health needs of their system.

The membership and detailed functions of the ICP is for local determination but there is an expectation it will focus on the wider connections between health and wider issues including socio-economic development, housing, employment and environment. It should take a collective approach to decision-making and support mutual accountability across a system.

Further information on the development of the Humber and North Yorkshire Integrated Care Partnership will be brought to a future meeting. To enable this to happen the Board are being asked to approve the proposal that the Chair and Chief Executive of the Integrated Care Board are our founding members of the ICB who will work alongside the six local authority Chief Executives and their nominated elected members to establish the Integrated Care Partnership arrangements.
