The Department of Health and Social Care (DHSC) is consulting on a specific number of of proposed updates to the NHS Constitution as part of the process to complete the 10-year review, as legislated for in the Health Act 2009.					
The ICB Board consider the DHSC consultation at a previous meeting and agreed that a written submission would alternatively be sent by the Chair which captured the wider observations of the Board about the positive opportunities to update and refresh the NHS Constitution.

Dear

I am writing on behalf of the Board of NHS Humber and North Yorkshire Integrated Care Board in response to the consultation on the 10-year review of the NHS Constitution. The ICB Board has considered the review on two occasions, both before and following the NHS pre-election guidance period, as it felt it was important that its deliberations be conducted in a public environment.

First and foremost, we fully endorse the continued value of the NHS Constitution in setting out the NHS principles, values and rights as well as reaffirming the concordance and respective responsibilities of NHS policy makers, staff, patients, the public and those who advocate for them.

The ICB Board agrees with most of the specific questions posed in the consultation, which are viewed as positive, and it neither agrees or disagrees with the remainder. I set out below however further Board observations which, while sitting outside the limited scope of the current consultation, we believe are helpful as part of an ongoing debate needed about other aspects of the NHS Constitution between the many and diverse parties who are invested in the NHS. We hope this engagement will continue beyond the end of the consultation and pre-election periods.

It is recognised that the original document helpfully brought together for the first time the clear rights, commitments and responsibilities associated with the NHS and Board members felt that the 10-year review provided the impetus for a broader public conversation as to how the additional rights and pledges set out in the NHS Constitution Handbook can remain fit for purpose for the next decade and beyond. This included, but was not limited to, rights relating to access and services.

The Board also felt that there was greater value in placing inclusivity and eliminating any form of discrimination at the core of the NHS Constitution rather than the narrower focus of biological sex and gender that the consultation considered. There is also merit in being explicit through the NHS Constitution about the commitment to meet the healthcare needs of those, for example, with protected characteristics or identify with other inclusion groups, as well as womens health specifically.

Finally, the timing of this 10-year review provides an ideal opportunity to consider and enshrine within the NHS Constitution the longer term pledge for the NHS to work with its partners to meet the population health challenge and tackle the wider determinants of health and wellbeing.
