Tobacco control leaders in Humber and North Yorkshire welcome Chancellor's smoking and vaping tax announcements



Health leaders in Humber and North Yorkshire who advocate for tougher measures to help tackle smoking and vaping have welcomed a new tax on vape liquids and rises in smoking taxes, announced by the Chancellor in last week's budget.

The Government is making the following changes to tax on tobacco and vapes:

- Confirmed tobacco tax escalator of RPI + 2% and RPI +12% for hand-rolled tobacco
- Flat-rate tax of £2.20 per 10ml bottle of vape liquid, to be introduced from October 2026
- A one-off increase for tobacco tax in October 2026 to maintain the price differential with vaping and incentivise smokers to switch

**Scott Crosby, Associate Director of the Humber and North Yorkshire Centre for Excellence in Tobacco Control, said:** "The cost of smoking to society and the huge strain on the NHS far outweighs the revenue created by tobacco taxes. Continued rises help to encourage smokers to guit and reduce the uptake among young people.

"The new vape fluid tax will help to reduce access to cheap products for children, and importantly also create more powers to tackle illegal imports.

"It's important that vapes and tobacco keep a price difference to ensure that they are still an incentive for smokers to switch to a less harmful option, but I'm pleased this has been set at a flat rate."

Humber and North Yorkshire Cancer Alliance's giant inflatable lung to tour the region this Lung Cancer Awareness Month



People across the region are being encouraged to get to grips with lung cancer – literally – by Humber and North Yorkshire Cancer Alliance this November.

For Lung Cancer Awareness Month, the Cancer Alliance is taking a three-metre-tall inflatable lung on tour across the region to supermarkets, shopping centres and other community spaces to spark conversation and raise awareness of the signs and symptoms of lung cancer.

Lung cancer is the third most common cancer in the UK. Around 18,600 men and 16,100 women die from lung cancer in the UK every year, making it the biggest cancer killer in the UK.

The majority of lung cancer diagnosis cases happen between the ages of 70 and 74, but cases rise rapidly from the age of 55 onwards. Early detection of lung cancer is key, and people diagnosed with the disease in its earliest stages are nearly 20 times more likely to survive for five years than those whose cancer is caught late.

Unfortunately, seven in 10 cancer patients are being diagnosed too late – often because there are no signs or symptoms during the early stages of the disease.

### News from Across the Partnership

Centre for Addiction and Mental Health Research in Hull



Humber Teaching NHS Foundation Trust is proud to be a key partner in a groundbreaking new mental health research initiative led by the University of Hull. The University has secured £11 million from the National Institute for Health and Care Research (NIHR) to establish the Centre for Addiction and Mental Health Research (CAMHR), with the Trust's colleagues playing a crucial role in its development and impact.

CAMHR aims to significantly improve the provision of, and access to essential addiction and mental health services provided in the community, including services for children and young people. The centre's targeted research will inform how services are delivered.

Mental health problems are the single largest cause of disability in the UK. One in four adults and one in ten children experience mental illness. It is estimated 340,000 people need help for opiate and/or cocaine use and over 600,000 need alcohol treatment, with a large group of adults and young people experiencing both mental ill health and substance use.

The centre will be led by Professor Thomas Phillips, Professor of Nursing in Addiction and Professor Judith Cohen, Professor of Clinical Trials at Hull York Medical School, and Director of the Hull Health Trials Unit at the University of Hull.

An important role of the centre will be to undertake a clinical study to explore tangible solutions to the complex issue of addiction and mental health conditions in young people. Another core purpose of the centre will be to amplify the voices of people with lived experience, and those of their family and carers, using their experiences of addiction and mental health care to inform the programme of research.

Fraud Awareness Month takes place this November and it coincides with International Fraud Awareness Week, running from 17 to 23 November.

NHS Humber Health Partnership is committed to making sure vital NHS funds are not lost to fraud and is reinforcing this message throughout November by holding a range of activities.

Fraud against the NHS takes many guises including patients attempting to avoid paying prescription charges by falsely claiming exemptions or claiming for travelling expenses that they're either not entitled to or haven't incurred; staff may attempt to gain employment with false documentation or claim pay for shifts they did not work or work elsewhere while off sick from the Trust; and contractors may exaggerate or falsify records of NHS work or goods provided.
