<ul style="list-style-type: none"> • The Partnership agreed for the Futures Group to develop a proposal for coastal-based ‘living lab’ research, focussed primarily in Scarborough, which is to be presented to the ICP in June 2025.

<ul style="list-style-type: none"> • Integrated Care Board – Updates were provided on the financial position and winter pressures. Emphasis was placed on patient safety, quality, and the importance of vaccination. It was highlighted how the NHS is facing significant financial challenges, and there is a need for system-wide collaboration to address these issues. The Chair emphasized that Winter pressures are being managed with a focus on patient safety and dignity, and there are efforts to improve ambulance handover times and manage staff absenteeism. • Futures Group – developing a ‘living lab’ research methodology in Scarborough focusing on longevity and ageing well, facilitating partners from VCSE and private sector. Creating a Steering Group of key members to feed into the Futures Group, to prepare a proof-of-concept proposal to ICB by June 2025. • Local Government Partnership Report - Update from Local Authority Representatives regarding:

- Updates on devolution: North Lincolnshire and Hull achieved devolved mayoral status.
- Formation of Humber Leadership Board to align economic and health strategies.
- Section 75 agreements highlighted as vital tools for budget pooling and integrated health-social care delivery.
- **Children's Plan Framework** – Updates were given regarding the challenges and the progress and initiatives. Progress has been made through the development of integrated strategies that align health, education, and social care for children, alongside pilot programs focused on SEND support in specific areas. Efforts are underway to enhance co-production by engaging families and community organizations, secure additional funding to address disparities, and adopt a data-driven approach to identify gaps and target interventions effectively. Strengthened regional collaboration is also a priority, with the aim of sharing best practices and ensuring consistent support across regions.
- **Design for the Future** - the development of the future design for the ICP was discussed, emphasizing the need to address both urgent pressures and long-term strategic goals focused on excellence, prevention, and sustainability. They highlighted the importance of evolving decision-making into a collaborative approach, bringing together clinical expertise and public input to redesign services. The public engagement survey revealed that people are willing to use digital technology for healthcare but need better support and advice to make positive changes to their health and well-being. The next steps involve going back to the public early in the new year with what has been heard and starting to set the direction for how these insights will be used, with more detailed engagement and co-production to design specific services for the future.
- **Integrated Neighbourhood Approach** – This agenda item focused on the importance of proactive care, prevention, and community partnerships. It was discussed how this approach aims to provide care at a local level, ensuring that people's needs are met without escalating to higher levels of care. The goal is to create a more integrated and seamless experience for patients by leveraging community resources and fostering collaboration among various stakeholders. This approach emphasizes the importance of addressing health and social care needs in a holistic manner, promoting overall well-being and reducing the need for more intensive intervention
